A. Southeast Louisiana Flood Protection Authority-East (SLFPAE):

1. Motion to authorize and direct the Orleans Levee District and the Lake Borgne Basin Levee District, by their governing authority, the Board of Commissioners of the Southeast Louisiana Flood Protection Authority – East (SLFPAE), by its President, Timothy Doody, to acquire properties as identified and described in the files of the U.S. Army Corps of Engineers for the Construction of the Inner Harbor Navigation Canal (IHNC) Hurricane Protection Work, contingent upon execution of a Cooperative Endeavor Agreement between SLFPAE and the Coastal Restoration and Protection Authority, and to authorize and direct the SLFPAE President to execute any and all documents and to take any and all actions necessary to carry out the foregoing.

- 2. Motion to authorize the Regional Director to negotiate and enter into a contract with Right of Way Services, Inc. for the IHNC Right of Way Acquisition.
- 3. Motion to request the Louisiana Attorney General to clarify a previously issued opinion.
- 4. Motion to authorize reimbursement of travel expenses of Ray E. Martin, Ph.D., P.E., and Robert C. Bachus, Ph.D., P.E., in connection with the 17th Street Canal Seepage review.

D. Lake Borgne Basin Levee District (LBBLD):

 with the administration of the contract for the Repair/Renovation of the LBBLD
