A. Southeast Louisiana Flood Protection Authority-East (SLFPA-E):

C. Orleans Levee District (O.L.D.):

- 1. Motion to approve the renewal of Property Hazard (wind/fire) Insurance coverage from AmRisc at an estimated annual cost of \$379,470 for a period of one year, commencing on April 20, 2014.
